

**Nevada Division of Water Resources (NDWR)**  
**Well Driller Continuing Education Unit (CEU) Program**  
**Nevada Administrative Code (NAC) 534.2923, 2925 and 2927**

## **Introduction and Objectives**

During each renewal cycle, (July 1<sup>st</sup> through June 30<sup>th</sup>), licensed well drillers are required to earn at least 8 continuing education units (CEU's) by attending training sessions or participating in ongoing education sponsored and/or approved by NDWR in order to renew a Nevada Well Driller License. Participation in on-going education allows the driller to stay informed of regulatory, industry, and technological advances and changes. Combining field experience with continuing education enhances the driller's knowledge and abilities. The primary objectives of the Nevada Driller CEU program are:

- Develop a reasonable level of confidence among well drillers and contractors.
- Increase public confidence in the well driller and contractor.
- Increase protection of groundwater resources.
- Increase compliance to well drilling regulations and pertinent statutes.

## **Nevada CEU Requirements**

The following is a summary of the CEU program requirements in accordance with the Regulations for Water Well and Related Drilling.

- **Licensed drillers must complete the NDWR-sponsored "Nevada Well Drilling Regulations and Statutes" once every 2 years.**
- **Licensed drillers must complete the NDWR-sponsored "How to Properly Complete a Notice of Intent Card, Well Driller's Report, Affidavit of Intent to Abandon and Waiver forms" review course once every 2 years.**
- Licensed well drillers must earn a minimum of 8 CEU's during a 1-year licensing cycle in order to renew their license for the next licensing cycle.
- Well drillers are responsible for obtaining and maintaining the necessary documentation for each course attended and submitting the documentation with their license renewal application.
- Generally, 1 hour of training or education will equal 1 CEU. However, some courses that are considered to be valuable by NDWR, but whose content is not directly related to well drilling, may be rated at less than 1 hour per CEU. Examples are courses related to pumps or groundwater hydrology/hydrogeology, which are typically rated at 1 CEU per 2 hours of instruction. Other, safety related courses, such as MSHA, OSHA, HAZWOPER and First Responder courses are rated at 1 CEU per 4 classroom hours.
- 1 CEU may also be assigned to training courses that do not last at least 1 hour. A course must be a minimum of 45 minutes to receive 1 CEU.
- A licensed driller who teaches an "approved" CEU course will receive 2 CEU's for every hour of classroom training up to a maximum of 8 CEU's. A licensed driller who teaches the same course more than once during the renewal period may not obtain more CEU's for teaching the same course a second time. They may receive credit for teaching the same course every other year.
- Up to 4 CEU's in excess of 8 CEU's can be carried over to the next licensing period. If the licensed well driller has demerit points assessed against their license pursuant to NAC

Chapter 534, any extra CEU's may first go towards reducing the total number of demerit points assessed to their license.

## CEU Approval Process

NDWR approves training appropriate for CEU's. NDWR may consider recommendations of the Nevada Well Drillers' Advisory Board and keeps a list of approved courses that are updated regularly and can be accessed on NDWR's website at [water.nv.gov](http://water.nv.gov).

It is responsibility of the licensed driller to decide how, when and where to take the training. Training/education courses should relate to occupational health and safety, business and office skills, interpersonal skills, technical aspects of the drilling industry, or other subjects that will enhance business, technical, or regulatory knowledge, skills, and abilities. A driller may look for training from members of professional associations, government agencies, private businesses, or individuals. A driller can choose from the list of courses; however, a driller is not limited to taking the courses that are on that list. Drillers can look for training opportunities in trade magazines, training flyers, brochures, advertisements in newspapers or mail, and courses offered at universities. Course work should be pre-approved by NDWR so that a driller will know if credit will be granted for a class not on the approved list. A driller may choose to take the course first and then ask for CEU approval, however, there is no guarantee that the course will be approved. The following is a list of topics that relate to well drilling that would be applicable to the CEU program. This list is by no means comprehensive, nor a guarantee that the listed courses will receive 1 CEU for every hour of instruction. This list is for information purposes only.

## Request for a Program or Course Accreditation

If a class or course does not appear as approved as listed on the NDWR website, the well driller or course instructor may obtain prior approval to ensure the credits will be accepted. The "**Request for a Program or Course Accreditation**" form is available on NDWR's website. The driller or

instructor will be asked to provide information on the course content, instructors, and course length.

## **Obtaining, Maintaining, and Submitting Training Records**

In order to receive credit for a course, the driller must obtain a record of course completion and attendance from the course instructor/provider. This proof of attendance can consist of certificates, transcripts, diplomas, and attendance rosters.

Licensed drillers must provide these proof documents at renewal. It is the responsibility of the licensed driller to maintain all documentation pertaining to CEU's.

## **Special Conditions and Appeals**

Newly licensed Well drillers will not be required to submit CEU's during their first renewal cycle, e.g., driller licensed August 2022 will not have to provide 8 hours of CEU's when renew their license in June 2023. The driller will need to provide evidence of completion of 8 CEU's to renew their well driller license for all subsequent renewal cycles. If, during the first renewal period after the driller has obtained their licenses, the newly licensed driller participates in courses eligible for CEU's, those hours may be carried over to the following renewal period, not to exceed 4 CEU's.

A driller may appeal the decision of NDWR to disallow a course approval or credits. An appeal must be made in writing and directed to NDWR. NDWR will evaluate appeals and hold a hearing, if necessary, on a case-by-case basis.

Drillers who were not able to get the required CEU's before the June 30<sup>th</sup> annual deadline because of a hardship situation must contact NDWR in writing. NDWR will review the merits of each situation and make a recommendation. The State Engineer may avail himself of the Well Drillers' Advisory board to assist in making a decision as to the merits of appeals and hardships. **Every well driller license expires on June 30th of each year unless a renewal application is timely received and approved. To reinstate an expired license, the driller must: File an Application for Well Driller's License with the \$100.00 fee AND PASS THE EXAMINATION required by NAC 534.282 or PETITION the NDWR for and RECEIVE a waiver of the requirement to pass the examination.**
