Required Courses

The required Regulation and Forms course will remain a four-hour course, three hours covering the regulations portion and one hour covering the forms portion. You will receive 4 Continuing Education Units (CEU's) for attending this course. All well drillers can check the status of their license, which will show how many CEU's they have, and if they need the required Regulations and Forms course at http://water.nv.gov/ContinuingEducation.aspx/

You must attend the Regulation and Forms Course in its entirety to obtain credit for the required course.
