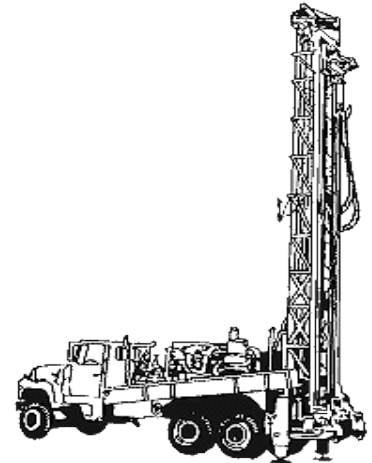

Written exams for parts I and II of the well driller examination are offered in January, March, April, June, July, September, October and December. The exam will begin promptly at 8:30.

The Statewide Well Driller's Advisory Board meets in February, May, August and November to conduct part III of the well driller examination. The oral exam is scheduled by appointment.
