PROOF OF APPROPRIATION OF WATER FOR STOCK WATERING PURPOSES

From Peete Springs Name of natural water source.

Through Pipe 25 feet long Name of ditch, pipe line, etc.

Nels Toft, the undersigned, being first duly sworn, deposes and says that the statements herein contained relative to the appropriation of water by him are full and correct to the best of his knowledge and belief.

If proof is not made by claimant, deponent should state on this line by virtue of what authority he represents the claimant

(1) Name of claimant Nels Toft Address Birch, County of Eureka, State of Nevada.

(2) The means of diversion employed is 25 feet of pipe Ditch, flume, pipe line, flume, etc.

(3) The water is impounded in one Trough Troughs, reservoirs, tanks, etc.

(4) The construction of the ditch or other works was begun Pipe laid in 1901 and completed same time

(5) The nature of the claimant's title to the land upon which the works are located is Unsurveyed land

(6) The claimant's water right was (was not) recorded in the office of the County Recorder of County, at page of Book of

(7) The approximate number of animals watered by the claimant during the first year was 20 and said watering was conducted for an approximate period of 30 days during each of the following months May, June, July, August, September & October

(8) The approximate number of animals watered by claimant in subsequent years was as follows:

None the Spring was dug at the time the pipe was laid in 1901 and stock was never watered there every year since 1901

(9) The amount of water which it has been necessary to divert for the said purpose has been.....

1 Miners inch cubic feet per second.  
40 miners inches equals 1 cubic foot per second

(10) The water is diverted from its source at the Spring 205 chains True bearing to nearest 5 minutes distance Feet

from the NE corner of Section 3, T. 23, R. 54

E., Mount Diablo Base and Meridian.

Note—Information under (10) must invariably be given when a public corner is within 6 miles, unless the State Engineer consents to some other form of description.

(11) The works are located at SE 1/4 NW 1/4 Sec. 31 Tp 24 NB 55, E.M.D.M.

Describe as within a 40 acre subdivision of public survey or by a tie in same manner as under (10)
