

County, State of Nevada, for the following reasons and on the following grounds, to wit:
The applicants do not have a grazing permit in the Corta Allotment where the POD and POU are located. Permitting this application may violate S.B. 76 and NRS 533.503, which mandate that the State Engineer will issue a permit to appropriate water for the purpose of watering livestock only to permit applicants who are legally entitled to place livestock on the lands for which the permit is sought, and who own or have an interest in the livestock. Wilfred R. Bailey and Barbara Bailey are not legally entitled to place livestock on the lands for which the permit is sought and have no interests in livestock that are permitted to graze the allotment.

THEREFORE the Protester requests that the application be Denied
Denied, issued subject to prior rights, etc., as the case may be
and that an order be entered for such relief as the State Engineer deems just and proper.

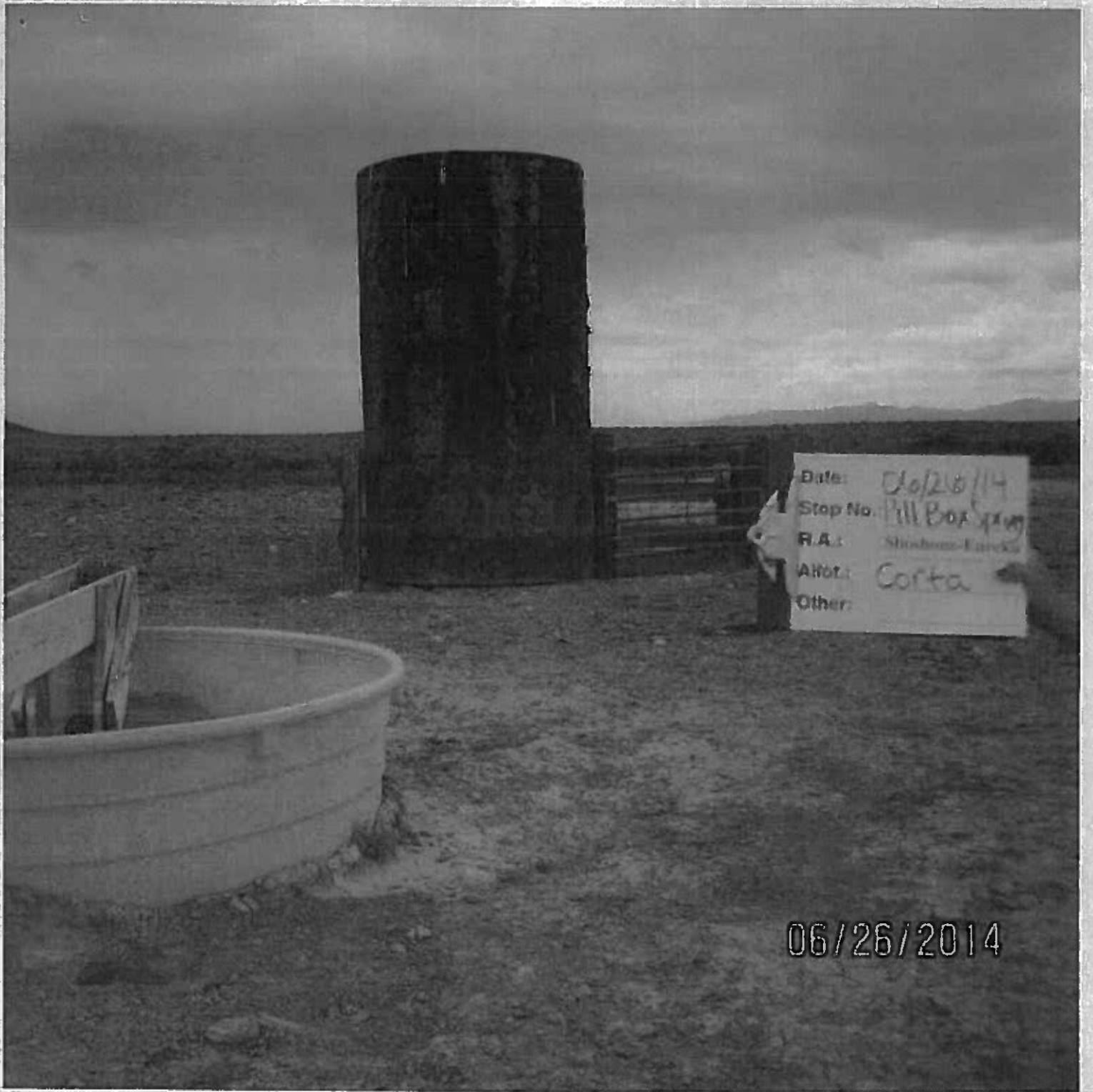

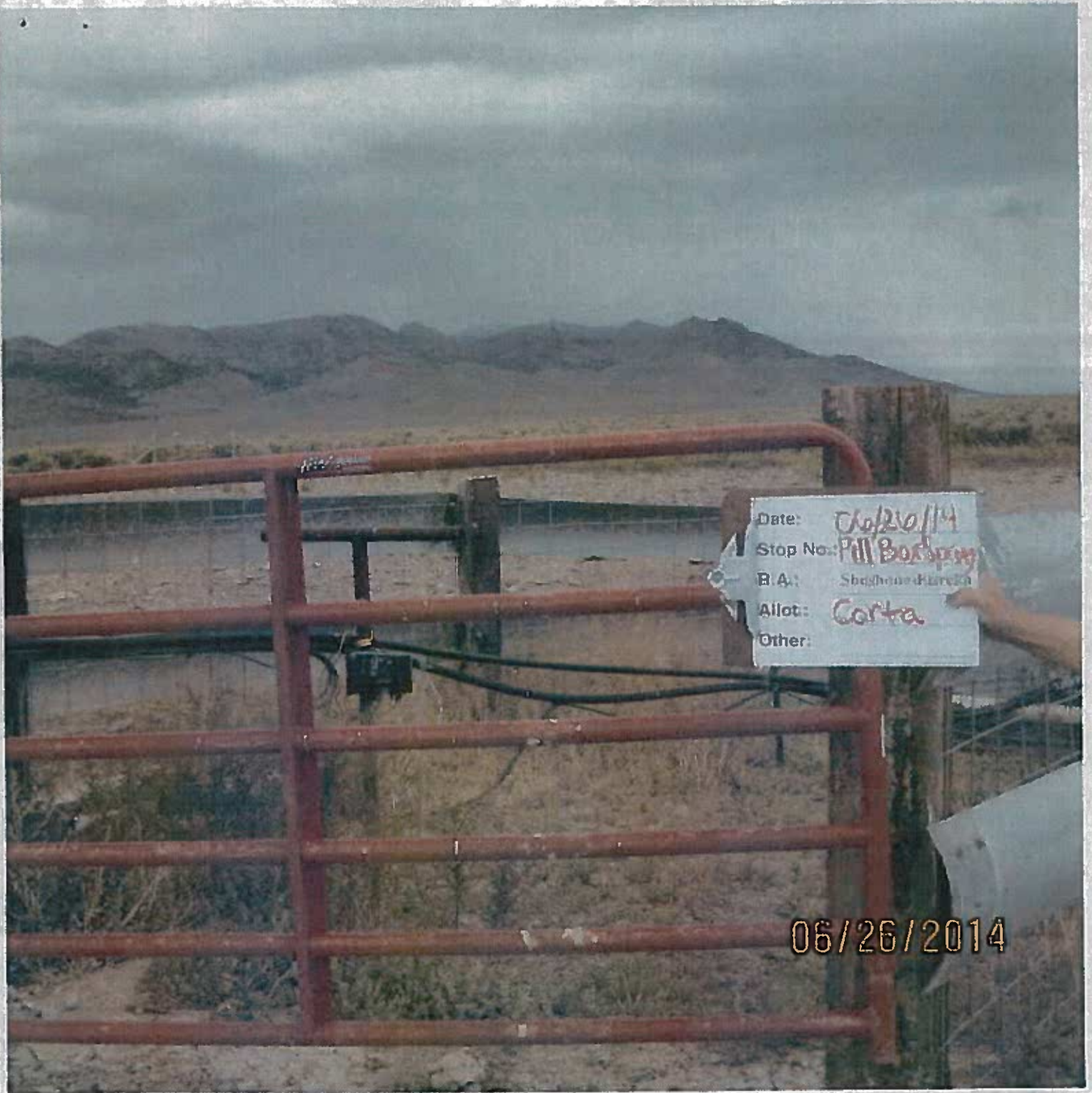
