16 State University. I am a registered Professional Engineer licensed in the states of Nevada (P.E.
17 7767), California (P.E. 41711) and Washington (P.E. 42196). I am a Water Right Surveyor (No.
18 814) in the state of Nevada and have been continuously licensed as such since 1988. I am also a
19 Certified Floodplain Manager. I founded R.O. Anderson Engineering, Inc. in 1989 and I am
20 responsible for the daily activities of the firm. Since 1989, a significant portion of my clients and
21 assignments have been attributable to water right-related services. These services have routinely
22 included preparing and processing water right permit applications; researching and documenting
23 water right title for both public and private clients; preparing claims of vested rights and
24 participating as necessary in surface water adjudication hearings; preparing opinions of water right
25 values; and consulting with and advising clients relative to Nevada water right-related issues. In
26 addition, I have been qualified to testify as a water right expert in several Nevada District Courts
27 including Washoe County, Lyon County, Carson City and Douglas County. I have been qualified to
28 testify before the Nevada State Engineer as an expert civil engineer and water right surveyor in
matters relating to water rights and water right permitting.


1 2. I make this affidavit as agent for objector EUREKA COUNTY and in support

13 faith, with the intention of presenting evidence in support thereof in every particular.

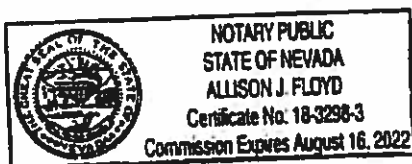
