22 Mark Moyle Farms, LLC (“MMF”), through its attorney Debbie Leonard of McDonald  
23 Carano LLP, files this Objection to a portion of the Preliminary Order of Determination made by  
24 the State Engineer in the Matter of the Determination of the Relative Rights in and to All Waters  
25 of Diamond Valley, Hydrographic Basin No. 10-153, Elko and Eureka Counties, Nevada related  
26 to V10858, V10859, V10860 and V10861 filed by Beck Properties (“Claimant”). This objection  
27 is made on the following grounds:

- 28 1. The records submitted to the relevant taxing authorities by the Claimant and/or its  
predecessor(s) in interest indicate that fewer number of stock used this area  
historically than Claimant now claims.
2. The Claimant and/or its predecessor(s) in interest did not timely establish a use for the  
claimed water within the pertinent time frame required to establish a vested right.

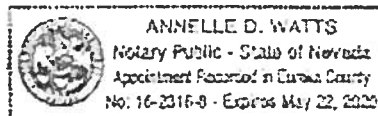
