NOTICE OF PRE-HEARING CONFERENCE

Ladies and Gentlemen:

By letter dated June 29, 2007, the Southern Nevada Water Authority requested the State Engineer schedule the public administrative hearing to consider the matter of protested Applications 53987-53992, inclusive, which were filed to appropriate the underground waters of the Cave, Dry Lake and Delamar Valleys. The Authority requested the hearing be scheduled for January 14-18, 2008, and that a pre-hearing conference be scheduled to address certain statutory issues, protest issues that can be briefed, and possibly ruled on, prior to the hearing date, the evidentiary exchange and administrative notice of records of the Division of Water Resources. The State Engineer is hereby setting a pre-hearing conference in order to address the Authority's request.

Therefore, **please take notice**, the State Engineer hereby sets a pre-hearing conference to consider the matter of protested Applications 53987-53992 filed by the Las Vegas Valley Water District and now held by the Southern Nevada Water Authority.

The pre-hearing conference will begin promptly at 9:00 a.m. Tuesday, August 28, 2007, to be held at the Division of Water Resources' Hearing Room, Second Floor, 901 South Stewart Street, Carson City, Nevada.

Legal counsel not licensed to practice law in the State of Nevada or licensed, but not maintaining an office in the State of Nevada, is required to comply with Supreme Court Rules 42 and 42.1. The Verified Application to Associate form that needs to be filed with the Nevada State Bar can be found on the Nevada Division of Water Resources website found at www.water.nv.gov under Forms Room - Miscellaneous Forms. Nevada Supreme Court Rule 43 provides an exception for lawyers employed by or representing the United States Government.


