Ladies and Gentlemen:

Re: Application 80700, Service list

As you are aware, an issue was raised during the January 24, 2012, pre-hearing conference that the participating parties are not receiving service of all documents submitted in this matter. The participating parties are also not sure of the correct service list to use.

When the State Engineer first noticed this matter for pre-hearing conference, the hearing officer included the Applicant and all Protestants on that notice. However, since that time some Protestants are now represented by legal counsel, some Protestants have had a single spokesperson appear for them, and other Protestants have indicated they intend to participate in a minimal manner in any administrative hearing. It was evident to the State Engineer's staff during the first pre-hearing conference, that many of the Protestants are unclear about the process of a formal administrative hearing.

In order to determine who will actually be fully participating during any administrative hearing, by fully participating the State Engineer means either putting on a case-in-chief or participating in cross-examination, the State Engineer by notice dated September 22, 2011, sent an Intent to Participate form to all of the Protestants and requested that they inform him if they intended to put on a case-in-chief. The Protestants were requested to return the Intent to Participate form to the Office of the State Engineer by January 2, 2012. Many did not return the actual form, but rather sent the State Engineer a letter indicating they intend to participate as a protestant. The reason for the State Engineer requesting this information is that we do not require service of process of all documentation on those who have no intention of participating in the administrative hearing. There is no reason to require fully participating parties to go to the time and expense of service of legal briefing, exhibits and related types of documents on parties who do not intend to fully participate. However, please be informed that any notice of hearing, interim order and ruling in this matter will be served on the Applicant and all Protestants; however, if a Protestant is represented by legal counsel or someone who indicated they are

representing a group of Protestants, as Mr. Jim Snyder indicated during the second pre-hearing conference, only legal counsel or the representative will be served. It is the responsibility of legal counsel or any representative to inform their clients or those they represent of any filings in this matter.

Based on the responses received to the Intent to Participate form, letters received, and appearances made at the January 24th prehearing conference, I have prepared a service list that I believe includes those who intend to fully participate in the hearing. For your information, I provide a summary of the information received and how this was used to create the service list.

The following Protestants indicated on the Intent to Participate form that they are <u>not</u> participating in the administrative hearing process: Bill Carlson, Nichol Merritt Ditch by Glenn Sciarani, Paul Sciarani, Sciarani Ditch by Paul Sciarani, and Settlemeyer-Rosse Ranch Management, LLC by Jerry R. Rosse. However, please note, the State Engineer was informed at the January 24th pre-hearing conference that Settlemeyer-Rosse Ranch Management, LLC is now represented by Linda Bowman, Esq. and will be participating as a party at any administrative hearing. The State Engineer will not require service of documents such as legal briefing on any of these parties. They will be kept informed of hearing dates, interim rulings and the final decision.
