As ordered at the pre-hearing conference of August 31, 2011, an outline of issues should be submitted to the Office of the State Engineer by **Friday, October 21, 2011.**

In order to prepare for the pre-hearing conference and administrative hearing, the State Engineer needs to gather information from the Protestants and therefore includes with this notice an Intent to Participate form. Accordingly, this second pre-hearing conference will begin promptly at **9:00 a.m., on Tuesday, January 24, 2012, to be held at the Tahoe Hearing Room, Nevada Division of Water Resources, 901 South Stewart Street, Second Floor, Carson City, Nevada.** Only the parties that have standing as Applicant and Protestants to the above-referenced application may

participate in the pre-hearing conference. Items of discussion will include the provisions of NAC § 533.170 regarding pre-hearing conferences and may include scheduling for legal briefs, motions, evidence exchanges and hearing dates.

As set forth in Nevada Administrative Code § 533.220, the pre-hearing conference will be reported by a certified court reporter. The court reporter will file an original and one copy of the transcript with the State Engineer. Anyone wanting a copy of the transcript should make arrangements with the court reporter. The Applicant and participating Protestants will bear equally the court reporter's appearance fee, travel expenses, and costs of reporting and transcribing the transcript.

You or your designated representative should plan to attend the prehearing conference regarding the course and conduct of the administrative hearing. Legal counsel not licensed to practice law in the State of Nevada is required to comply with Supreme Court Rule 42. The Verified Application to Associate form that needs to be filed with the Nevada State Bar can be found on the Nevada Division of Water Resources website at <http://water.nv.gov> under Water Rights Forms. Nevada Supreme Court Rule 43 provides an exception for lawyers employed by or representing the United States Government.
