

Ladies and Gentlemen:

Please take notice, on September 14, 2012, the Federal District Court issued an order addressing the State Engineer's Petition for Instruction regarding the role of the United States Board of Water Commissioners (Board) in the matter of protested application 80700. The Court held that the Board may participate as a full party in the administrative hearing on this matter and may take any and all positions that it deems appropriate. Therefore, pursuant to the Second Amended Notice of Hearing, the State Engineer assigns the Board exhibit numbers and a time for presenting its case. All other provisions of the Amended Notice of Hearing issued on August 10, 2012, remain in effect. The Board is assigned exhibit numbers 1051 - 1100 and the Board's case is scheduled to follow the Protestants cases.
