This testimony will address the necessity of an effective monitoring, management and mitigation plan to protect and preserve cultural resources.
- 5. **Virginia Sanchez** is a member of the Duckwater Shoshone Tribe. She will testify generally to the waters, plants, wildlife and places in Spring Valley that have enduring cultural significance to Shoshone people, including but not limited to the Swamp Cedars site and its nomination and listing as a traditional cultural property with the National Register of Historic Places. This testimony will address the necessity of an effective monitoring, management and mitigation plan to protect and preserve cultural resources.
- 6. **Victor McQueen, Jr.,** is Chairman of the Ely Shoshone Tribe. He will testify generally to the waters, plants, wildlife and places in Spring Valley that have enduring cultural significance to Shoshone people, including but not limited to the Swamp Cedars site and its nomination and listing as a traditional cultural property with the National Register of Historic
