19 Reich will testify generally to the procedural and substantive requirements of a monitoring,
20 management and mitigation plan necessary to protect public interests, environmental values,
21 and existing water rights in the Spring, Cave, Dry Lake and Delamar Valleys. See his CV at
22 CTGR_EXH_019, and his report at CTGR_EXH_018.

24 2. **Jeff Symons** is an associate engineer with Stetson Engineers and is a co-author
25 with Steve Reich of the report filed here, CTGR_EXH_018. He will testify as necessary to the
26 essential components of a monitoring, management and mitigation plan essential to protect
27 public interests, environmental values, and existing water rights in the Spring, Cave, Dry Lake

1 and Delamar Valleys. See his CV at CTGR_EXH_020, and his report at CTGR_EXH_018.

2 3. **Virgil Johnson** is the Chairman of the Confederated Tribes of the Goshute
3 Reservation. He will testify generally to the waters, plants, wildlife and places in Spring Valley
4 that have enduring cultural significance to Goshute people, including but not limited to the
5 Swamp Cedars site and its nomination and listing as a traditional cultural property with the
6 National Register of Historic Places. This testimony will address the necessity of an effective
7 monitoring, management and mitigation plan to protect and preserve cultural resources.

9 4. **Rupert Steel**, Tribal Elder, is a member of the Confederated Tribes of the
10 Goshute Reservation. He will testify generally to the waters, plants, wildlife and places in
11 Spring Valley that have enduring cultural significance to Goshute people, including but not
12 limited to the Swamp Cedars site and its nomination and listing as a traditional cultural property
13 with the National Register of Historic Places. This testimony will address the necessity of an
14 effective monitoring, management and mitigation plan to protect and preserve cultural
15 resources.

18 5. **Virginia Sanchez** is a member of the Duckwater Shoshone Tribe. She will testify
19 generally to the waters, plants, wildlife and places in Spring Valley that have enduring cultural
20 significance to Shoshone people, including but not limited to the Swamp Cedars site and its
21 nomination and listing as a traditional cultural property with the National Register of Historic
22 Places. This testimony will address the necessity of an effective monitoring, management and
23 mitigation plan to protect and preserve cultural resources.

25 6. **Victor McQueen, Jr.**, is Chairman of the Ely Shoshone Tribe. He will testify
26 generally to the waters, plants, wildlife and places in Spring Valley that have enduring cultural
27 significance to Shoshone people, including but not limited to the Swamp Cedars site and its
28 nomination and listing as a traditional cultural property with the National Register of Historic

1 Places. This testimony will address the necessity of an effective monitoring, management and
2 mitigation plan to protect and preserve cultural resources.

4 7. **Monte Sanford, Ph.D.** is a consultant for the Confederate Tribes of the Goshute
5 Reservation. He will testify as a percipient witness to the activities involved in seeking and
6 obtaining the designation of the Swamp Cedars area as a traditional cultural property with the
7 National Register of Historic Places.
