**NOTICE OF  
STATUS CONFERENCE**

**I.**

By decision dated December 10, 2013, file date December 13, 2013, Judge Robert Estes, sitting for the Seventh Judicial District Court of the State of Nevada in and for the County of White Pine, remanded the matter of Applications 53987 through 53992, inclusive, and Applications 54003 through 54021, inclusive, held in the name of the Southern Nevada Water Authority, to the State Engineer for further consideration. No action was taken by the State Engineer on the applications during the course of pending petitions to the Nevada Supreme Court. The Petition for Writ of Mandamus filed by State Engineer was denied by the Nevada Supreme Court by Order filed on May 21, 2015. The Petition Writ of Mandamus filed by Southern Nevada Water Authority was denied by the Nevada Supreme Court by Order filed on May 21, 2015. The Petition for Limited Writ Review filed by the Corporation of the Presiding Bishop of the Church of Jesus Christ of Latter-day Saints was denied by the Nevada Supreme Court by decision filed on January 28, 2016.

**II.**

The decision by Judge Estes remanded State Engineer's Ruling Nos. 6164, 6165, 6166 and 6167 concerning the granting of water rights to the Southern Nevada Water Authority in Spring Valley, Cave Valley, Dry Lake Valley and Delamar Valley to the State Engineer for:

1. The addition of Millard and Juab counties, Utah in the mitigation plan so far as water basins in Utah are affected by pumping of water from Spring Valley Basin, Nevada;
2. A recalculation of water available from Spring Valley assuring that the basin will reach equilibrium between discharge and recharge in a reasonable time;
3. Defining standards, threshold or triggers so that mitigation of unreasonable effects from pumping of water are neither arbitrary nor capricious in Spring Valley, Cave Valley, Dry Lake Valley and Delamar Valley, and;
4. Recalculation of the appropriations from Cave Valley, Dry Lake Valley and Delamar Valley to avoid over appropriation or conflicts with down-gradient, existing water rights.

**III.**

**STATUS CONFERENCE DATE**

**IV.**

At the status conference, the parties should be prepared to discuss the following:

1. Whether an additional administrative hearing is necessary or whether the matters can be reconsidered based on the evidence already in the record;
2. Whether additional work needs to be accomplished or evidence developed prior to reconsideration by the State Engineer or any additional administrative hearing;
3. Timing for the exchange of additional evidence, if necessary; and
4. If necessary, scheduling of any additional administrative hearing.

**V.**

**COST OF REPORTING**

As set forth in Nevada Administrative Code Chapter 533, the status conference will be reported by a certified court reporter. The court reporter will file an original and one copy of the transcript with the State Engineer. Anyone wanting a copy of the transcript should make arrangements with the court reporter. The costs of the transcript will be borne equally by all parties actively participating during the status conference.
