

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant State of Nevada, Department of Fish and Game of Reno, County of Nevada 89510, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is underground. Name of stream, lake or other source.

2. The amount of water applied for is 0.2 second-foot. One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet 0.5 acre-feet

3. The water to be used for Fish, Wildlife and Recreation. Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for: (a) Irrigation (state number of acres to be irrigated) (b) Stockwater (state number and kinds of animals to be watered) (c) Other use (describe fully under "No. 12. Remarks") (d) Power:

(1) Horsepower developed (2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: within the SW 1/4 NE 1/4 of Section 2, T. 12N., R. 67E., M.D.B. & M. from which point the North 1/2 corner of said Section 2 bears N. 15° 51' W. 1,470 feet.

6. Place of use SW 1/4 NE 1/4 of Section 2, T. 12N., R. 67E., M.D.B. & M.

7. Use will begin about Jan. 1st and end about Dec. 31st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) The water will be diverted through underground pipe lines to small ponds used to propagate rare and endangered species of fish.

- 9. Estimated cost of works..... \$2,000
- 10. Estimated time required to construct works..... One year
- 11. Estimated time required to complete the application to beneficial use..... Five years
- 12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other groundwater development in the area.

A measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water granted herein at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.2 cubic feet per second, but not to exceed 32.6 million gallons annually.

- Work must be prosecuted with reasonable diligence and be completed on or before..... August 28, 1975
- Proof of completion of work shall be filed before..... September 28, 1975

- Proof of the application of water to beneficial use shall be filed on or before..... September 28, 1978
- Map in support of proof of beneficial use shall be filed on or before.....
