

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the place of use of a portion of the waters of an underground source as heretofore granted under Permit 22017 is issued subject to the terms and conditions imposed in said Permit 22017 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.7 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before September 12, 1970

Proof of commencement of work shall be filed before October 12, 1970

Work must be prosecuted with reasonable diligence and be completed on or before September 12, 1970

CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Henry C. Conrad, P.E., Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well pump and sprinkler system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows: NE1/4 Sec. 34, T.13N., R.67E., MDB&M, or at a point from which the SE corner of said Sec. 34 bears S. 0° 07' E., a distance of 5179.83 feet situated in White Pine County, State of Nevada.

Now Know Ye, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre feet per acre per year from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
