- 1. Mr. Wilson discussed the progress regarding draft revisions to the Regulations for Water Well and Related Drilling. He has received drafts back from the Nevada Legislative Counsel Bureau and is reviewing the edits. Mr. Wilson is making a concerted effort to complete the drafts soon as to not have to wait another year due to the convening of the Nevada State Legislature.
- 2. Mr. Wilson presented before the Board that a Well Driller was to be issued 110 demerit points for failure to file four (4) separate Notice of Intent Cards (NOI) to drill wells and (1) NOI to plug a well.

3. Mr. Wilson advised the Board regarding a water well that was plugged within 20 feet of a replacement production well. In the process of plugging the old well using a pressure grout method, the replacement well has had a significant reduction in water production in addition to pumping a portion of the plugging grout into a nearby quasi-municipal water system. It is recommended by the Board to fully perforate the replacement production well in hopes of getting more production. If fully perforating the replacement well does not result in adequate

water production, the Board recommends to drill a new well then plugging the replacement well with Bentonite chips in order to avoid creating the same issue regarding a newly drilled well.
