**NOTICE OF HEARING ON PROPOSED DESIGNATION ORDER FOR LOWER WHITE RIVER FLOW SYSTEM
LOCATED WITHIN CLARK AND LINCOLN COUNTIES**

Pursuant to Nevada Revised Statute (NRS) § 534.030, the State Engineer will hold a public hearing on a proposed order to designate the Lower White River Flow System Hydrographic Basin, located in Clark and Lincoln Counties. NRS 534.030(2)(b) provides that the hearing may be held in the county where the major portion of the basin lies (here, Clark County).

The public hearing will be held to provide notice and to take testimony on the proposed order. The hearing is open to the public and will convene at:

Oral testimony will be accepted during the hearing and will be limited to ten (10) minutes per party. Written testimony will be accepted until Friday, March 27, 2026, and may be submitted in-person during the hearing or subsequently mailed to the Nevada Division of Water Resources at the below address.

The hearing on the proposed designation order will be followed on the same day by a public meeting initiating the management phase of the administrative process concerning the Lower White River Flow System in light of the potential designation and Order 1309. An agenda for the meeting will be circulated and posted on the Division's website closer to the meeting.

The public is encouraged to read the proposed order. This Notice of Hearing on the Proposed Order has been sent to the county commissioners and is also posted on the Division's website.

A Public Notice of Hearing will be published in the legal section once per week for four consecutive weeks beginning January 26, 2026, in the Las Vegas Review Journal, a newspaper of general circulation in Clark County, and the Lincoln County Record, a newspaper of general circulation in Lincoln County.
