STATE WATER PLAN STAKEHOLDER ADVISORY GROUP

The Nevada Division of Water Resources (NDWR) will be holding a meeting with members of the State Water Plan Stakeholder Advisory Group (SAG) to provide an overview of the Nevada State Water Plan update process and discuss the roles and responsibilities of the SAG. This meeting will be conducted in accordance with Open Meeting Law (NRS 241.020).

This meeting will be video and/or teleconferenced as specified beginning at 9:00 a.m. The State Water Plan Stakeholder Advisory Group may act on items marked “For Possible Action.” Items may be taken out of the order presented on the agenda at the discretion of the Chair. Items may be combined for consideration by the Stakeholder Advisory Group at the discretion of the Chair. Items may be pulled or removed from the agenda at any time.

Please Note: Witnesses wishing to have their complete testimony/handouts included in the permanent record of this meeting should provide a written or electronic copy to the SAG administrative support staff. Minutes of the meeting are produced in a summary format and are not verbatim.

1. **CALL TO ORDER AND ROLL CALL** – Chair, Bunny Bishop, Chief of the NDWR Water Planning Section, and Vice-Chair, Nicole Goehring, NDWR Water Resource Specialist.
