If a Proof of Completion has not been filed and approved by NDWR and an extension of time is needed, please complete out the "APPLICATION FOR EXTENSION OF TIME FOR FILING PROOF OF COMPLETION OF WORK" form.

This application is a sworn affidavit and must be signed by the person filling out the application and must include their address and phone number in the spaces provided.

- > Each application must appear with an original signature of the permittee or agent.
- > The application must be dated and properly notarized.
- > A separate application for extension of time is required for each permit.
- > Fees paid by check must be made out to the "Nevada Division of Water Resources."

The original document and associated filing fees must be received by NDWR on or before the due date as set forth in the terms of the permit. If the application is made by mail, this form and associated filing fees must be mailed to the Nevada Division of Water Resources at 901 S. Stewart Street, Suite 2002, Carson City, Nevada 89701.
