**Manny Fernandez:** We shall now call to order the quarterly meeting of the Nevada Well Drillers Advisory Board in Carson City, Nevada. Today's date is November 13<sup>th</sup>, 2024. **Steve Hamrick:** Right. Do you have a continuous flight too?

**Tyson Mena:** Yes, we do.

**Steve Hamrick:** Okay.

**Dan Kohlman:** Yeah, that'd be fine.

**Paul Forbes:** So, if we do limited to that, what would he need to retake to get a full license?

**Steve Hamrick:** Well for air and mud rotary he'd need to learn a lot more about the air and mud.

**Dan Kohlman:** So I would say that just limited by sonic and auger.

**Steve Hamrick:** Right. I mean he needs to learn about the different drill pipe, and..

**Dan Kohlman:** Yeah. It's still a full license, just by rig.

**Steve Hamrick:** Right.

**Tyson Mena:** We do have these things called clem drill rigs. It's what we do a lot of our soil nails with. That I've drilled on before and it actually uses air and blows all the cuttings out of the top of the casing. Occasionally we do monitoring wells and stuff with them, like in a pinch when we don't have a sonic rig available. And the only way to get the soil out of the ground with that rig is to blow it out with air. That was something I was just thinking about right now, was we do use air but not mud rotary really.

**Dan Kohlman:** So, we're still at the same thing. There's only a couple air questions and it doesn't apply to what they're doing. So, if we just did water well limited to sonic and auger that would cover it.

**Steve Hamrick:** I think so. Bucket or auger.

**Manny Fernandez:** Can we just note the limitations on the questionnaires please?

**Chad Walling:** I think in your talk you still do them one by one to make sure it's all spelled out, just for our recording.

**Manny Fernandez:** Okay. Paul, what's your recommendation?

**Paul Forbes:** I recommend approval for his water well license limited to sonic and auger.

**Manny Fernandez:** Dan?

**Dan Kohlman:** I recommend approval limited to sonic and auger as well.

**Steve Hamrick:** And I approve for bucket auger and sonic.

**Manny Fernandez:** The board recommends to the State Engineer, Tyson Mena, for his Water Well License. The time is 9:20 a.m.
