Call to Order:

Manny Fernandez: We shall now call to order the quarterly meeting of the Nevada Well Drillers Advisory Board in Carson City, Nevada. Today's date is December 18th, 2025. The time is 8:16 AM. Representing the Nevada Well Driller's Board is Dennis Robblee, and Arnold Lamon. Representing the Nevada Division of Water Resources is Gary Blake and myself, Manny Fernandez. To comply with Open Meeting Law, notices of this meeting were posted in this building, and at the required locations throughout Nevada. At this time, we would like to open the floor for any public comment. Hearing none, we will proceed with the approval of the Well Driller's Advisory Board minutes.

Arnold Lamon: I have none.

Dennis Robblee: Winston, I'd like to run through a couple things with you before, okay. You're an awesome guy. I have no doubt every word of your references is true. Not only that, I would take you anywhere to do anything. But what I would recommend is you spend a little bit of time looking into the why's and the what's of things. I bet you're the hardest worker on the rig, and I bet that if someone tells you to go do something then you can go do anything. I have no doubt that's the case. There are a few things that really concern me, is your lack of knowledge of the connections of anything to do with the drill pipe. Or the equipment, other than the names maybe. You're going to find yourself in some situations. I don't personally know Brett, I've met him a couple times. But what I would ask you is, is that you go back to him and say hey I would like to learn some of this stuff, can you include me? When I figure out these connections or we put it together, or subs, or the casing, or any of that stuff. The collar

weights, how much you can run. I try to involve all my guys. Well, I try to involve my guys with potential. Without knowing that stuff you can really get yourself into some big trouble. That concerns me a little bit. I would love nothing more than to give you a license today. If you were in the central valley, nothing but, I would have probably done that. But today I'm going to suggest that you take a little time, and we will retest just this section. And I hate to do that to you, but I think its in both of our best interests. The state and yours as well.

Manny Fernandez: Arnold?

Arnold Lamon: Couple of things for me to second what Denny's saying here is- the tooling. Very very important. I work for a big company, and we have every thread known to man pretty much. Sonic, we have DI22, we have CSR, we have full flow, smooth flow. Not that I expect you to know all of that. Just know what you are dealing with. With what your company is using. In my situation, I have to know it because I can't send a smooth flow system out there and then a full flow got mixed in. They will screw together but they will come apart. By the time you pull up on it. Like I said, I don't expect you to know what I have to deal with but what you're dealing with I really need you to understand. I can tell you there's no special thread out there. They don't exist. Because if I call okay bitco and want them to cut a 2 and 7/8s thread, they have a dye for that. You can't just set them up on the laith and cut that thread. Or full. You just can't do it. So, there's no special thread. Try to educate yourself a little more on your mud, the parameters of it and the weights. I know California, I drill a lot there. Yeah, they want you to use straight water but that can get you in trouble to a point where you can't get back out of it. So, get yourself involved. You said you haven't done monitoring wells; that's part of the full water well license. I know you said you haven't done them. And that's okay.

Winston Steinke: I do know a little bit about them.

Arnold Lamon: Right. But we need to be able to, with full confidence, to give you a full water well license. That you are aware of everything for the state of Nevada. So, at this point, I want you to come back. Ask your questions. Tell him there's no such thing as a special thread.

Winston Steinke: Oh believe me, I will.

Arnold Lamon: It's going to be 6 and 5/8s, or 7 and 5/8s. There is an 8 and 5/8s out there. You might not see them. We don't use a whole bunch of them, but we do have a few. Just keep that in mind. Drill bit sizes. The pins that are coming out of them, very important. So, I'm going to say come back and do it again.

Winston Steinke: Okay.

Manny Fernandez: The board recommends to the State Engineer, Winston Steinke, for a retest on part two for his water well license. The time is 9:22 a.m. Is there a motion from the Board to close the meeting, pursuant to NRS 241.030, to conduct the oral exam?

Arnold Lamon: I motion to close.

Dennis Robblee: And I second it.

Manny Fernandez: Arnold motioned, and Denny seconded. All in favor, say aye.

Manny Fernandez: The board recommends to the State Engineer Cody Franklin, for his water well license, limited to production wells only. No monitor wells. The time is 10:54 a.m. Is there a motion from the Board to close the meeting, pursuant to NRS 241.030, to conduct the oral exam?

This is the point where you come in here, we ask you some questions and dig deep and make sure you know the things you need. And that you're a drilling professional and able to move forward. With a good conscience, we can't turn you loose with this license. Okay? There's so much you need to learn, and if you're not getting that from the guy, you're with maybe you go to the boss and see if you can be put with someone who can get you those things. And some time. You just have to have some time. So, my recommendation is also that we deny your application, okay? I hate to do that to you, but I think somebody led you down the wrong path to get here.

William Comish: Yeah, well I definitely understand.

Manny Fernandez: Do you have any questions right now?

William Comish: No, I think that's pretty cut and dry really.

Dennis Robblee: Well hopefully it wasn't an unpleasant experience for you, and you obviously know some book stuff to get you through to this point but there's a lot to learn.

Arnold Lamon: And we appreciate your honesty.

Dennis Robblee: We really do.

Manny Fernandez: The board recommends to the State Engineer, William Comish, denial of his application at this time. The time is 11:19 a.m. Is there a motion from the Board to close the meeting, pursuant to NRS 241.030, to conduct the oral exam?
