Call to Order and
Public Comment:

At this time, we would like to open the floor for any public comment. Hearing none, we will proceed with the approval of the Well Driller's Advisory Board minutes.

Meeting Minutes:

Manny Fernandez: Copies of minutes of the Well Driller's Advisory Board meeting, dated November 19th, 2025, have been distributed for your review. Are there any additions or corrections to the minutes? Hearing none, is there a motion for the board to approve the minutes, to stand approved as read?

Paul Forbes: I make a motion to approve the minutes as read.

Arnold Lamon: And I second it.

Manny Fernandez: Paul motioned, and Arnold seconded. All in favor say aye.

Manny Fernandez: All opposed say nay.

The motion carries. Okay, thank you gentlemen. We will now move on to the business of the board. Not much to discuss right now. I think everything that had to be discussed was yesterday. Anything that concerned the public. The only thing is we are still looking for a State Engineer. Right now, we have an acting State Engineer. That's the only update really. Arnold Lamon: I agree. Production well license and you'll have to come back for your monitoring wells.

Manny Fernandez: The board recommends to the State Engineer, Mr. Jimenez, for a limited license. Limited to production wells only. The time is 10:40 a.m. Is there a motion from the Board to close the meeting, pursuant to NRS 241.030, to conduct the next oral exam?

Arnold Lamon: I make a motion to close the meeting.

Paul Forbes: And I second it.

Manny Fernandez: Arnold motioned, and Paul seconded. All in favor, say aye.

Manny Fernandez: All opposed say nay. The motion carries.

Paul Forbes: I recommend approval for a water well license limited to production wells. So no monitor wells.

Manny Fernandez: Arnold?

Arnold Lamon: I approve for water well, limited, no monitoring wells.

Manny Fernandez: The board recommends to the State Engineer, Mr. Macy, for a limited water well license. The limitation being production wells only. No monitoring wells. The time is 11:46 a.m. Before I adjourn the meeting, our office can offer you another option. While we concur with the decision of production wells license only, but if you don't want to take that and you want to come back for a retest for the full to get the monitor well we can also do that. It's up to you. The difference being if I issue you the limited production wells you would have to reapply and do the application. You wouldn't have to do the written but you would have to come back to the board. Which is kind of the same thing. If you need the monitor well, you also have that other

option. We can not issue you a license today and retest you again for the full.

Daniel Macy: So if I take the limited water well today, then I would have to redo the entire process?

Manny Fernandez: You would have to submit the application, yes. But not the written exam. You'll see in your account it will give you a choice to upgrade the license. So, you can skip the written but you'd have to come back to the board.

Daniel Macy: Okay. Yeah. I'd like to take the limited today. And in the future, I'll file to come back and do the monitor.

Public Comment:

Manny Fernandez: Okay. At this time, we would like to close with a period for public comment. *Noise break*
