Call to Order:

Manny Fernandez: We shall now call to order the quarterly meeting of the Nevada Well Drillers Advisory Board in Las Vegas, Nevada. Today's date is August 6th, 2025. The time is 8:13 AM. Representing the Nevada Well Driller's Board is Arnold Lamon, Paul Forbes, and Steve Hamrick. Representing the Nevada Division of Water Resources is Timothy Semays, and myself, Manny Fernandez. To comply with Open Meeting Law, notices of this meeting were posted in this building, and at the required locations throughout Nevada. Arnold Lamon: I'm going to recommend a retest also. Get yourself more familiar with abandonments and the process of the well from beginning to end.

Manny Fernandez: Paul?

Paul Forbes: I'm going to also recommend a retest.

Manny Fernandez: The board recommends to the State Engineer, Mr. Thrash, to retest for his limited license to monitor wells. The time is 10:17 a.m. Is there a motion from the Board to close the meeting, pursuant to NRS 241.030, to conduct the next oral exam?

Steve Hamrick: You did real good on everything else. You studied a lot.

Lance Robbins II: Thank you. To be honest I haven't really applied myself to anything in so long, so I just wanted to try to better myself and take a step up.

Steve Hamrick: Well we appreciate the studying.

Manny Fernandez: Paul?

Paul Forbes: I recommend approval for a full license.

Manny Fernandez: The board recommends to the State Engineer, Mr. Robbins, for his limited Water Well License. The time is 1:38 p.m. Is there a motion from the Board to close the meeting, pursuant to NRS 241.030, to conduct the next oral exam?

Arnold Lamon: I’m going to suggest a retest also. Study up on your up hole velocity on your air. It will be a benefit to you in the future. Mud and monitoring wells. That’s part of our job.

Manny Fernandez: Paul?

Paul Forbes: I recommend a retest also. I think you’re right there, just monitoring well stuff got you. And the mud stuff, mud is super important. I know you are drilling some mud holes. So make sure you get mud engineers out. They come out usually for free. They can run you through a lot.

Manny Fernandez: The board recommends to the State Engineer, Mr. Darian Hernandez, to retest part II the oral examination for his water well license. The time is 2:56 p.m.
