\*A class on Nevada Well Drilling Regulations and Forms is required at least once every two years. State-sponsored courses will be offered at least once every year.

**Note:** Eight CEU credits are required each year to renew a well driller's license. Generally, one hour of training is equivalent to one credit. The required regulation class must be taken at least once every two years. A maximum of 4 CEU credits can carry over from one licensing cycle to the next. It is the responsibility of the driller to maintain documentation of education and to keep track of credits. Proper documentation can include the completed documentation form provided by the state for each class, diplomas, certificates, rosters, transcripts, etc. Drillers must provide copies of this documentation with their renewal application.
