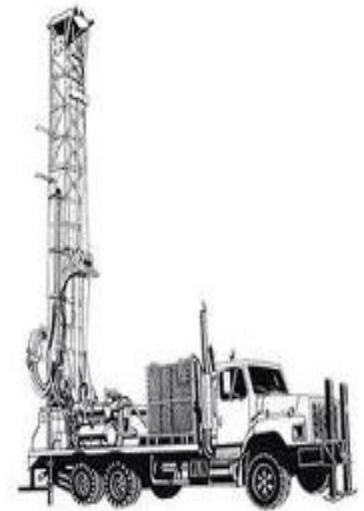

#### **Required Courses**

The required Regulation and Forms course will remain a four-hour course, three hours covering the regulations portion and one hour covering the forms portion. You will receive 4 Continuing Education Units (CEU's) for attending this course. All well drillers can check the status of their license, which will show how many CEU's they have, and if they need the required Regulations and Forms course at <http://water.nv.gov/ContinuingEducation.aspx/>

This course is required every other renewal period. Additional opportunities to attend the Regulations and Forms courses can be found on our website. For more information on an event hosting the Regulations and Forms courses, please visit that specific event's website.

You must attend the Regulation and Forms Course in its entirety to obtain credit for the required course.

24-hour notices are required for all well drilling work (not just plugging). Please email your 24-hour notices to [ndwdrilling@water.nv.gov](mailto:ndwdrilling@water.nv.gov). This does not include reconditioning work or pump work.

## **2025-2026 Examination Dates and Times**

The written portion of the well driller examination is offered in January, March, April, June, July, September, October, and December. The exam will begin promptly at 8:30 am.

The Statewide Well Drillers' Advisory Board meets in February, May, August, and November to conduct the oral portion of the well driller examination. This exam is scheduled by appointment.

#### **The schedule is as follows:**
