Nevada Well Driller's Advisory Board Examination Instructions

The Nevada Well Driller's Examination consists of three separate parts.
Part 1 is a 100 question test.
Part 2 is a single question pass/fail map reading test.
Part 3 is an oral interview before the Nevada Well Driller's Advisory Board.

Part 1 of the examination is a closed book test that covers the Regulations for Water Well and Related Drilling publication of the Office of the Nevada State Engineer. A downloadable copy is available on our website at water.nv.gov or you may get a copy from Nevada Division of Water Resources. No reference materials of any kind are allowed. All materials will be provided.

Part 1 of the examination has a total of 100 questions. Eighty (80) multiple-choice questions are directly related to the current edition of the Regulations for Water Well and Related Drilling. Ten (10) questions are "fill in the blank" of how to prepare a Notice of Intent Card (NOI). Ten (10) questions are "fill in the blank" of how to prepare a Well Driller's Report (Well Log). All questions are equally weighted. You must receive a score of 80% or greater to pass Part 1.

Part 2 of the examination is a single question pass/fail test which is given shortly after passing Part 1. Part 2 requires you to accurately identify a given point on a United States Geological Survey (USGS) 15-minute quadrangle map (Quad Map). You must correctly locate the given point by 40-acre subdivision, e.g., (by ¼ ¼, Section, Township and Range) to pass Part 2.

Part 3 of the examination is an oral interview before three members of the Nevada Well Driller's Advisory Board. Some of the topics covered are, but not limited to include: Water Right Permits, Notice of Intent Cards, Well Driller Reports, authorizations, current statutory fees, operating well drilling equipment including rigs, tools casings and additives, methods of drilling operations, well construction, development and abandonment, Regulations for Water Well Drilling publication.

Attached are copies of an Answer Sheet, a Notice of Intent Card, a Well Drillers Report for Part 1 and a USGS Quad Map and Answer Sheet for Part 2 for reference.


